## STUDENT Checking Accounts

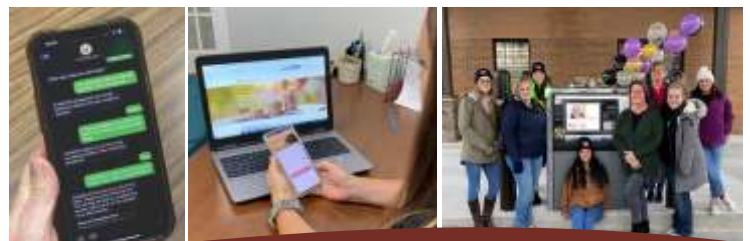

If the child signs up for E-Statements, they will receive \$10 after 3 months of establishing the account. There are just a few terms and conditions that apply to this checking account.

- The students must be at least 16 years or older, with a qualified adult
- The student must show their student ID
- There is a \$50 minimum opening deposit
- No monthly service fee
- E-statements are required for a student checking account
- ATM/Debit cards are available with the Student Checking Account

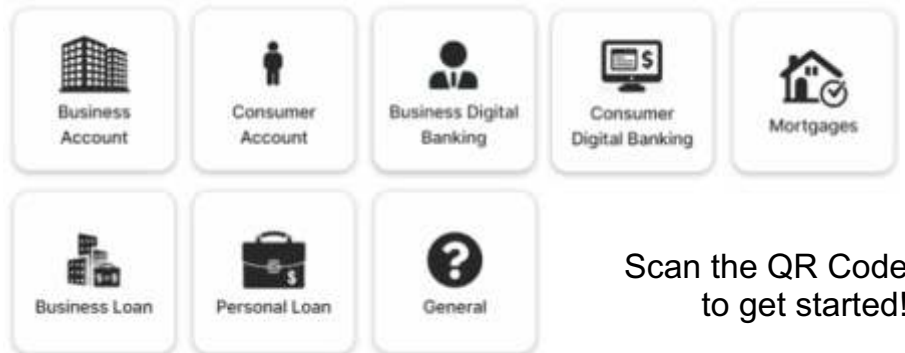
